3. Implementation of Reservation Policies:



4. Grievance Redressal:



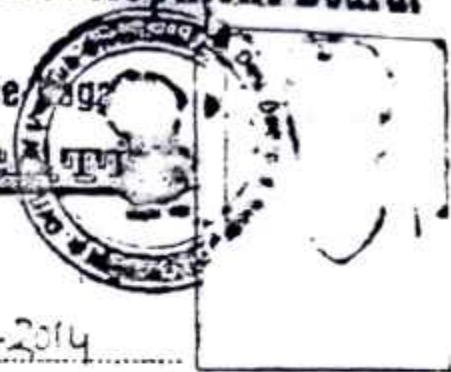
